### ASX LISTING UPDATE

Dear Member,

On behalf of the 360 Capital RE Limited, Responsible Entity of the 360 Capital Industrial Fund (Fund), I am pleased to advise that it is expected the Fund will list on the ASX on or about Thursday 13 December 2012 with the Fund's Units to trade under the ASX code "TIX".

The Fund is currently forecast to provide a FY2013 distribution of 4.500 cents per Unit, paid quarterly. The record date for determining Members' entitlement to the December 2012 quarter distribution of 1.125 cents per Unit will be 5.00pm on Monday 31 December 2012. It is expected that Units will trade "ex-distribution" on Friday 21 December 2012.

As disclosed in an Information Memorandum prepared to support the Fund's listing application, the Fund's proforma NTA per Unit is \$0.54 per Unit. This is based on the 30 June 2012 accounts, adjusted for asset sales and the Responsible Entity waiving acquisition and exit fees following the listing of the Fund.

Please find enclosed your new Issuer Sponsored Holding Statement which provides details regarding your Unitholding. For those Members that previously had fractional Unitholdings, the total number of Units held has now been rounded up to the nearest whole Unit.

If you are a broker sponsored holder, please advise your broker of your new Issuer Sponsored details in order that your CHESS information can be updated.
