

## Notice of Fund Payment - Subdivision 12-H

## MANAGED INVESTMENT TRUST NOTICE FOR INVESTORS IN RESPECT OF THE MARCH 2019 QUARTER DISTRIBUTION

For the purposes of complying with subsection 12-395 of Subdivision 12-H of Schedule 1 of the Taxation Administration Act 1953 (the **Act**), Centuria Property Funds No. 2 Limited, as the responsible entity of Centuria Industrial REIT (**CIP**) gives this notice of Fund Payment in relation to the guarter ended 31 March 2019.
